Section 5 – Important Information for Parents/Guardians

1. This form should be returned to your son/daughter's conductor/music teacher in a timely fashion. **The deadline by which all forms must be received in the ACF office is 2 Dec 2011; your conductor/teacher may set an earlier deadline.**
2. The cost to participate in the Alberta Children's Choir is \$180/chorister. Payment may be made by cheque or credit card. Details regarding payment are outlined in section 6.
3. Music packets and other information will be forwarded to your son/daughter's music teacher in December 2011. Choristers are expected to practice with the rehearsal CD (provided) and know all notes and rhythms before the regional rehearsal.
4. Regional rehearsals will be held in communities around the province on Saturday, 21 January 2012. **Attendance at a regional rehearsal is mandatory, and choristers who are absent may be dismissed from the choir.**
5. The Alberta Children's Choir rehearsals will take place in Edmonton, 2-4 February 2012, at MacEwan Alberta College. A tentative schedule is available on the Alberta Choral Federation website at www.albertachoralfederation.ca.
6. Travel to and accommodations while in Edmonton are the responsibility of the chorister's parents/guardians. Billeting options may be available – please inquire with the Alberta Choral Federation office by 2 December 2011 should you require a billet while in Edmonton. Some meals are provided as outlined on the schedule.
7. The Alberta Choral Federation will provide supervision based on a 1:15 ratio during rehearsals. Once a chorister has been picked up from rehearsal, the ACF shall hold no supervisory responsibility.
8. The Alberta Children's Choir concert will take place on Saturday, 4 February 2012, at 7:00 p.m. in the sanctuary of McDougall United Church. Tickets are \$10 each. Each chorister will receive one complimentary ticket.

Section 6 – Fees and Payment Information

The registration fee for the Alberta Children's Choir is \$180, payable at the time of registration. Refunds will not be issued after the registration deadline (2 December 2011). Some meals and snacks are included in the \$180 fee (as outlined on the schedule). Please indicate your method of payment below.

Section 7 – Consent

A high standard of conduct will be expected from Alberta Children's Choir participants at all times. Participants may not leave the grounds of the rehearsal or performance facilities during designated rehearsal and performance times without the express consent of the on-site representative of the ACF. Any participant who departs the grounds without permission or who behaves in a manner that an ACF representative or presenter, acting reasonably, considers unacceptable behaviour will be dealt with in a suitable and respectful manner and may be sent home at the participant's expense with no refund of the registration fee.

ACF and its representatives will use reasonable efforts to supervise and provide for the well being of participants. However, neither ACF nor any of its respective directors, executive, employees, staff, instructors, supervisors, clinicians, or technicians shall be liable for any personal injury to a participant or damage to a participant's property of any nature however caused or arising.

Photographs, recordings, videotapes and the like may be made of participants in the Alberta Children's Choir and may be used in slide shows, videos, brochures, and other materials advertising, promoting, or raising funds for the ACF.

To the best of my knowledge, the participant named on this form is in good health, except as described above. In the case of a medical emergency, I _____ (Parent/Guardian), hereby give permission to secure necessary medical treatment, including hospitalization, for the above-named participant.

In consideration of accepting the participant's registration, the undersigned consents and agrees to these terms of participation in the Alberta Children's Choir program and forever releases the ACF and its respective directors, executive, employees, staff, instructors, supervisors, clinicians, and technicians and the Government of Alberta, Minister of Culture and Community Spirit, the Alberta Foundation for the Arts, and the City of Edmonton, their respective servants, agents, or employees from any and all claims, actions, damages, or causes of action arising in any way out of participation in the Alberta Children's Choir.
